National Drug Code Directory

The Drug Listing Act of 1972 requires registered drug establishments to provide the Food and Drug Administration (FDA) with a current list of all drugs manufactured, prepared, propagated, compounded, or processed by it for commercial distribution. (See Section 510 of the Federal Food, Drug, and Cosmetic Act (Act) (21 U.S.C. § 360)). Drug products are identified and reported using a unique, three-segment number, called the National Drug Code (NDC), which serves as a universal product identifier for drugs. FDA publishes the listed NDC numbers and the information submitted as part of the listing information in the NDC Directory which is updated daily.

<i>NDC Package Code</i>	43742-1699-1	The labeler code, product code, and package code segments of the National Drug Code number, separated by hyphens. Asterisks are no longer used or included within the product and package code segments to indicate certain configurations of the NDC.
<i>11 Digit NDC Code</i>	43742-1699-01	It should be noted that many NDCs are displayed on drug packaging in a 10-digit format. Proper billing of an NDC requires an 11-digit number in a 5-4-2 format. Converting NDCs from a 10-digit to 11-digit format requires a strategically placed zero, dependent upon the 10-digit format.
<i>Product NDC</i>	43742-1699	The labeler code and product code segments of the National Drug Code number, separated by a hyphen. Asterisks are no longer used or included within the product code segment to indicate certain configurations of the NDC.
<i>Product Type Name</i>	DRUG FOR FURTHER PROCESSING	Indicates the type of product, such as Human Prescription Drug or Human OTC Drug. This data element corresponds to the "Document Type" of the SPL submission for the listing. <i>Non Proprietary Name</i>	Cochlearia Armoracia, Echinacea (angustifolia), Hydrastis Canadensis, Lomatium Dissectum, Tabebuia Impetiginosa, Hepar Suis, Thymus (suis), Thyroidinum (suis), Arnica Montana, Ferrum Metallicum, Hypericum Perforatum, Iridium Metallicum, Nitricum Acidum, Nux Vomica, Phosphoricum Acidum, Phosphorus, Selenium Metallicum, Zincum Metallicum	Sometimes called the generic name, this is usually the active ingredient(s) of the product.
<i>Package Description</i>	960 mL in 1 BOTTLE, PLASTIC (43742-1699-1)	A description of the size and type of packaging in sentence form. Multilevel packages will have the descriptions concatenated together. For example: 4 BOTTLES in 1 CARTON/100 TABLETS in 1 BOTTLE.
<i>Marketing Category Name</i>	DRUG FOR FURTHER PROCESSING	Product types are broken down into several potential Marketing Categories, such as NDA/ANDA/BLA, OTC Monograph, or Unapproved Drug. One and only one Marketing Category may be chosen for a product, not all marketing categories are available to all product types. Currently, only final marketed product categories are included. The complete list of codes and translations can be found at www.fda.gov/edrls under Structured Product Labeling Resources.

<i>Product Marketing Start Date</i>	20201008	This is the date that the labeler indicates was the start of its marketing of the drug product.
<i>Product Marketing End Date</i>	20260215	This is the date the product will no longer be available on the market. If a product is no longer being manufactured, in most cases, the FDA recommends firms use the expiration date of the last lot produced as the EndMarketingDate, to reflect the potential for drug product to remain available after manufacturing has ceased. Products that are the subject of ongoing manufacturing will not ordinarily have any EndMarketingDate. Products with a value in the EndMarketingDate will be removed from the NDC Directory when the EndMarketingDate is reached.
<i>Dosage Form Name</i>	LIQUID	The translation of the DosageForm Code submitted by the firm. The complete list of codes and translations can be found www.fda.gov/edrls under Structured Product Labeling Resources.
<i>Substance Name</i>	ARNICA MONTANA; ECHINACEA ANGUSTIFOLIA; GOLDENSEAL; HORSERADISH; HYPERICUM PERFORATUM; IRIDIUM; IRON; LOMATIUM DISSECTUM ROOT; NITRIC ACID; PHOSPHORIC ACID; PHOSPHORUS; PORK LIVER; SELENIUM; STRYCHNOS NUX- VOMICA SEED; SUS SCROFA THYMUS; SUS SCROFA THYROID; TABEBUIA IMPETIGINOSA BARK; ZINC	This is the active ingredient list.
