The Drug Listing Act of 1972 requires registered drug establishments to provide the Food and Drug Administration (FDA) with a current list of all drugs manufactured, prepared, propagated, compounded, or processed by it for commercial distribution. (See Section 510 of the Federal Food, Drug, and Cosmetic Act (Act) (21 U.S.C. § 360)). Drug products are identified and reported using a unique, three-segment number, called the National Drug Code (NDC), which serves as a universal product identifier for drugs. FDA publishes the listed NDC numbers and the information submitted as part of the listing information in the NDC Directory which is updated daily.

| <i>Product NDC</i>             | 43857-0241            | The labeler code and product code segments of the National Drug Code number, separated by a hyphen. Asterisks are no longer used or included within the product code segment to indicate certain configurations of the NDC.  |
| <i>Product Type Name</i>       | HUMAN OTC DRUG        | Indicates the type of product, such as Human Prescription Drug or Human OTC Drug. This data element corresponds to the "Document Type" of the SPL submission for the listing. | <i>Proprietary Name Suffix</i> | I                     | A suffix to the proprietary name, a value here should be appended to the ProprietaryName field to obtain the complete name of the product. This suffix is often used to distinguish characteristics of a product such as extended release ("XR") or sleep aid ("PM"). Although many companies follow certain naming conventions for suffices, there is no recognized standard. |

| <i>Marketing Category Name</i>      | UNAPPROVED HOMEOPATHIC  | Product types are broken down into several potential Marketing Categories, such as NDA/ANDA/BLA, OTC Monograph, or Unapproved Drug. One and only one Marketing Category may be chosen for a product, not all marketing categories are available to all product types. Currently, only final marketed product categories are included. | <i>Product Marketing Start Date</i> | 20130926  | This is the date that the labeler indicates was the start of its marketing of the drug product.  |
| <i>Product Marketing End Date</i>   | 20231116  | This is the date the product will no longer be available on the market. If a product is no longer being manufactured, in most cases, the FDA recommends firms use the expiration date of the last lot produced as the EndMarketingDate, to reflect the potential for drug product to remain available after manufacturing has ceased. Products that are the subject of ongoing manufacturing will not ordinarily have any EndMarketingDate. Products with a value in the EndMarketingDate will be removed from the NDC Directory when the EndMarketingDate is reached. |
| <i>Dosage Form Name</i>             | LIQUID  | The translation of the DosageForm Code submitted by the firm. The complete list of codes and translations can be found <a href="http://www.fda.gov/edrls">www.fda.gov/edrls</a> under Structured Product Labeling Resources.   |
