The Drug Listing Act of 1972 requires registered drug establishments to provide the Food and Drug Administration (FDA) with a current list of all drugs manufactured, prepared, propagated, compounded, or processed by it for commercial distribution. (See Section 510 of the Federal Food, Drug, and Cosmetic Act (Act) (21 U.S.C. § 360)). Drug products are identified and reported using a unique, three-segment number, called the National Drug Code (NDC), which serves as a universal product identifier for drugs. FDA publishes the listed NDC numbers and the information submitted as part of the listing information in the NDC Directory which is updated daily.

| <i>Product NDC</i> | 55566-6800 | The labeler code and product code segments of the National Drug Code number, separated by a hyphen. Asterisks are no longer used or included within the product code segment to indicate certain configurations of the NDC. |
| <i>Product Type Name</i> | HUMAN PRESCRIPTION DRUG | Indicates the type of product, such as Human Prescription Drug or Human OTC Drug. This data element corresponds to the "Document Type" of the SPL submission for the listing. | <i>Non Proprietary Name</i> | Sodium Picosulfate, Magnesium Oxide, And Anhydrous Citric Acid | Sometimes called the generic name, this is usually the active ingredient(s) of the product. |
| <i>Package Description</i> | 2 BOTTLE in 1 CARTON (55566-6800-1) / 175 mL in 1 BOTTLE (55566-6800-0) | A description of the size and type of packaging in sentence form. Multilevel packages will have the descriptions concatenated together. For example: 4 BOTTLES in 1 CARTON/100 TABLETS in 1 BOTTLE. |
| <i>Marketing Category Name</i> | NDA | Product types are broken down into several potential Marketing Categories, such as NDA/ANDA/BLA, OTC Monograph, or Unapproved Drug. One and only one Marketing Category may be chosen for a product, not all marketing categories are available to all product types. Currently, only final marketed product categories are included. The complete list of codes and translations can be found at www.fda.gov/edrls under Structured Product Labeling Resources. |
| <i>Application Number</i> | NDA209589 | This corresponds to the NDA, ANDA, or BLA number reported by the labeler for products which have the corresponding Marketing Category designated. If the designated Marketing Category is OTC Monograph Final or OTC Monograph Not Final, then the Application number will be the CFR citation corresponding to the appropriate Monograph (e.g. "part 341"). For unapproved drugs, this field will be null. |

| <i>Substance Name</i> | ANHYDROUS CITRIC ACID; MAGNESIUM OXIDE; SODIUM PICOSULFATE | This is the active ingredient list. Each ingredient name is the preferred term of the UNII code submitted. |
| <i>Strength Number</i> | 12; 3.5; 10 | These are the strength values (to be used with units below) of each active ingredient, listed in the same order as the SubstanceName field above. |
| <i>Strength Unit</i> | g/175mL; g/175mL; mg/175mL | These are the units to be used with the strength values above, listed in the same order as the SubstanceName and SubstanceNumber. |
