## **National Drug Code Directory**

The Drug Listing Act of 1972 requires registered drug establishments to provide the Food and Drug Administration (FDA) with a current list of all drugs manufactured, prepared, propagated, compounded, or processed by it for commercial distribution. (See Section 510 of the Federal Food, Drug, and Cosmetic Act (Act) (21 U.S.C. § 360)). Drug products are identified and reported using a unique, three-segment number, called the National Drug Code (NDC), which serves as a universal product identifier for drugs. FDA publishes the listed NDC numbers and the information submitted as part of the listing information in the NDC Directory which is updated daily.

| <i>Product NDC</i>                  | 62207-365                              | The labeler code and product code segments of the National Drug Code number, separated by a hyphen. Asterisks are no longer used or included within the product code segment to indicate certain configurations of the NDC.   |
| <i>Product Type Name</i>            | DRUG FOR FURTHER PROCESSING            | Indicates the type of product, such as Human Prescription Drug or Human OTC Drug. This data element corresponds to the "Document Type" of the SPL submission for the listing. | <i>Non Proprietary Name</i>         | Ibuprofen                              | Sometimes called the generic name, this is usually the active ingredient(s) of the product.   |
| <i>Package Description</i>          | 190476 TABLET in 1 DRUM (62207-365-67) | A description of the size and type of packaging in sentence form. Multilevel packages will have the descriptions concatenated together. For example: 4 BOTTLES in 1 CARTON/100 TABLETS in 1 BOTTLE.   |
| <i>Marketing Category Name</i>      | DRUG FOR FURTHER PROCESSING            | Product types are broken down into several potential Marketing Categories, such as NDA/ANDA/BLA, OTC Monograph, or Unapproved Drug. One and only one Marketing Category may be chosen for a product, not all marketing categories are available to all product types. Currently, only final marketed product categories are included. | <i>Product Marketing Start Date</i> | 20110101                               | This is the date that the labeler indicates was the start of its marketing of the drug product.   |
| <i>Dosage Form Name</i>             | TABLET                                 | The translation of the DosageForm Code submitted by the firm. The complete list of codes and translations can be found <a href="http://www.fda.gov/edrls">www.fda.gov/edrls</a> under Structured Product Labeling Resources.  |
| <i>Substance Name</i>               | IBUPROFEN                              | This is the active ingredient list. Each ingredient name is the preferred term of the UNII code submitted.  |
