The Drug Listing Act of 1972 requires registered drug establishments to provide the Food and Drug Administration (FDA) with a current list of all drugs manufactured, prepared, propagated, compounded, or processed by it for commercial distribution. (See Section 510 of the Federal Food, Drug, and Cosmetic Act (Act) (21 U.S.C. § 360)). Drug products are identified and reported using a unique, three-segment number, called the National Drug Code (NDC), which serves as a universal product identifier for drugs. FDA publishes the listed NDC numbers and the information submitted as part of the listing information in the NDC Directory which is updated daily.

| <i>11 Digit NDC Code</i>            | 64319-0001-06  | It should be noted that many NDCs are displayed on drug packaging in a 10-digit format. Proper billing of an NDC requires an 11-digit number in a 5-4-2 format. Converting NDCs from a 10-digit to 11-digit format requires a strategically placed zero, dependent upon the 10-digit format.  |
| <i>Product NDC</i>                  | 64319-001  | The labeler code and product code segments of the National Drug Code number, separated by a hyphen. Asterisks are no longer used or included within the product code segment to indicate certain configurations of the NDC.   |
| <i>Product Type Name</i>            | HUMAN PRESCRIPTION DRUG  | Indicates the type of product, such as Human Prescription Drug or Human OTC Drug. This data element corresponds to the "Document Type" of the SPL submission for the listing. | <i>Non Proprietary Name</i>         | Oxygen   | Sometimes called the generic name, this is usually the active ingredient(s) of the product.   |
| <i>Package Description</i>          | 680 L in 1 CYLINDER (64319-001-06)   | A description of the size and type of packaging in sentence form. Multilevel packages will have the descriptions concatenated together. For example: 4 BOTTLES in 1 CARTON/100 TABLETS in 1 BOTTLE.   |
| <i>Marketing Category Name</i>      | UNAPPROVED MEDICAL GAS   | Product types are broken down into several potential Marketing Categories, such as NDA/ANDA/BLA, OTC Monograph, or Unapproved Drug. One and only one Marketing Category may be chosen for a product, not all marketing categories are available to all product types. Currently, only final marketed product categories are included. | <i>Product Marketing Start Date</i> | 20000201   | This is the date that the labeler indicates was the start of its marketing of the drug product.   |

| <i>Substance Name</i>   | OXYGEN                      | This is the active ingredient list. Each ingredient name is the preferred term of the UNII code submitted.   |
| <i>Strength Number</i>  | 99                          | These are the strength values (to be used with units below) of each active ingredient, listed in the same order as the SubstanceName field above.  |
| <i>Strength Unit</i>    | L/100L                      | These are the units to be used with the strength values above, listed in the same order as the SubstanceName and SubstanceNumber.  |
