**NIGHT TIME COLD AND FLU RELIEF
National Drug Code Directory**

The Drug Listing Act of 1972 requires registered drug establishments to provide the Food and Drug Administration (FDA) with a current list of all drugs manufactured, prepared, propagated, compounded, or processed by it for commercial distribution. (See Section 510 of the Federal Food, Drug, and Cosmetic Act (Act) (21 U.S.C. § 360)). Drug products are identified and reported using a unique, three-segment number, called the National Drug Code (NDC), which serves as a universal product identifier for drugs. FDA publishes the listed NDC numbers and the information submitted as part of the listing information in the NDC Directory which is updated daily.

| <i>Proprietary Name</i> | Night Time Cold And Flu Relief | Also known as the trade name. It is the name of the product chosen by the labeler. |
| <i>11 Digit NDC Code</i> | 69842-0899-16 | It should be noted that many NDCs are displayed on drug packaging in a 10-digit format. Proper billing of an NDC requires an 11-digit number in a 5-4-2 format. Converting NDCs from a 10-digit to 11-digit format requires a strategically placed zero, dependent upon the 10-digit format. |
| <i>Product NDC</i> | 69842-899 | The labeler code and product code segments of the National Drug Code number, separated by a hyphen. Asterisks are no longer used or included within the product code segment to indicate certain configurations of the NDC. |
| <i>Product Type Name</i> | HUMAN OTC DRUG | Indicates the type of product, such as Human Prescription Drug or Human OTC Drug. This data element corresponds to the "Document Type" of the SPL submission for the listing. | <i>Proprietary Name Suffix</i> | Multi Symptom | A suffix to the proprietary name, a value here should be appended to the ProprietaryName field to obtain the complete name of the product. This suffix is often used to distinguish characteristics of a product such as extended release ("XR") or sleep aid ("PM"). Although many companies follow certain naming conventions for suffices, there is no recognized standard. |
| <i>Non Proprietary Name</i> | Acetaminophen, Dextromethorphan Hydrobromide, Doxylamine Succinate | Sometimes called the generic name, this is usually the active ingredient(s) of the product. |
| <i>Package Description</i> | 16 BLISTER PACK in 1 CARTON (69842-899-16) / 1 CAPSULE, LIQUID FILLED in 1 BLISTER PACK | A description of the size and type of packaging in sentence form. Multilevel packages will have the descriptions concatenated together. For example: 4 BOTTLES in 1 CARTON/100 TABLETS in 1 BOTTLE. |
| <i>Marketing Category Name</i> | OTC MONOGRAPH DRUG | Product types are broken down into several potential Marketing Categories, such as NDA/ANDA/BLA, OTC Monograph, or Unapproved Drug. One and only one Marketing Category may be chosen for a product, not all marketing categories are available to all product types. Currently, only final marketed product categories are included. | <i>Application Number</i> | M012 | This corresponds to the NDA, ANDA, or BLA number reported by the labeler for products which have the corresponding Marketing Category designated. For unapproved drugs, this field will be null. |
| <i>Product Marketing Start Date</i> | 20190731 | This is the date that the labeler indicates was the start of its marketing of the drug product. |
| <i>Dosage Form Name</i> | CAPSULE, LIQUID FILLED | The translation of the DosageForm Code submitted by the firm. The complete list of codes and translations can be found www.fda.gov/edrls under Structured Product Labeling Resources. |
| <i>Route Name</i> | ORAL | The translation of the Route Code submitted by the firm, indicating route of administration. The complete list of codes and translations can be found at www.fda.gov/edrls under Structured Product Labeling Resources. |
| <i>Substance Name</i> | ACETAMINOPHEN; DEXTROMETHORPHAN HYDROBROMIDE; DOXYLAMINE SUCCINATE | This is the active ingredient list. Each ingredient name is the preferred term of the UNII code submitted. |
| <i>Strength Number</i> | 325; 15; 6.25 | These are the strength values (to be used with units below) of each active ingredient, listed in the same order as the SubstanceName field above. |
| <i>Strength Unit</i> | mg/1; mg/1; mg/1 | These are the units to be used with the strength values above, listed in the same order as the SubstanceName and SubstanceNumber. |
| <i>Pharmaceutical Classes</i> | Antihistamine [EPC], Histamine Receptor Antagonists [MoA], Sigma- 1 Agonist [EPC], Sigma-1 Receptor Agonists [MoA], Uncompetitive N-methyl-D- aspartate Receptor Antagonist [EPC], Uncompetitive NMDA Receptor Antagonists [MoA] | These are the reported pharmaceutical class categories corresponding to the SubstanceNames listed above. |
