National Drug Code Directory

The Drug Listing Act of 1972 requires registered drug establishments to provide the Food and Drug Administration (FDA) with a current list of all drugs manufactured, prepared, propagated, compounded, or processed by it for commercial distribution. (See Section 510 of the Federal Food, Drug, and Cosmetic Act (Act) (21 U.S.C. § 360)). Drug products are identified and reported using a unique, three-segment number, called the National Drug Code (NDC), which serves as a universal product identifier for drugs. FDA publishes the listed NDC numbers and the information submitted as part of the listing information in the NDC Directory which is updated daily.

<i>Labeler Name</i>	VIATREXX BIO INCORPORATED	Name of Company corresponding to the labeler code segment of the ProductNDC.
<i>NDC Package Code</i>	73069-525-87	The labeler code, product code, and package code segments of the National Drug Code number, separated by hyphens. Asterisks are no longer used or included within the product and package code segments to indicate certain configurations of the NDC.
<i>Proprietary Name</i>	Viatrexx-thyro	Also known as the trade name. It is the name of the product chosen by the labeler.
<i>11 Digit NDC Code</i>	73069-0525-87	It should be noted that many NDCs are displayed on drug packaging in a 10-digit format. Proper billing of an NDC requires an 11-digit number in a 5-4-2 format. Converting NDCs from a 10-digit to 11-digit format requires a strategically placed zero, dependent upon the 10-digit format.
<i>Product NDC</i>	73069-525	The labeler code and product code segments of the National Drug Code number, separated by a hyphen. Asterisks are no longer used or included within the product code segment to indicate certain configurations of the NDC.
<i>Product Type Name</i>	HUMAN PRESCRIPTION DRUG	Indicates the type of product, such as Human Prescription Drug or Human OTC Drug. This data element corresponds to the "Document Type" of the SPL submission for the listing. <i>Non Proprietary Name</i>	Adrenal Gland, Fucus Vesiculosus, Iodum, Iridium, Parathyroid, Pituitary, Spleen, Spongia, Thymus Gland, Thyroid Gland, Thyroxine (t4), Triiodothyronine (t3)	Sometimes called the generic name, this is usually the active ingredient(s) of the product.
<i>Package Description</i>	25 VIAL, MULTI-DOSE in 1 BOX (73069-525-87) > 100 mL in 1 VIAL, MULTI-DOSE	A description of the size and type of packaging in sentence form. Multilevel packages will have the descriptions concatenated together. For example: 4 BOTTLES in 1 CARTON/100 TABLETS in 1 BOTTLE.
<i>Marketing Category Name</i>	UNAPPROVED DRUG OTHER	Product types are broken down into several potential Marketing Categories, such as NDA/ANDA/BLA, OTC Monograph, or Unapproved Drug. One and only one Marketing Category may be chosen for a product, not all marketing categories are available to all product types. Currently, only final marketed product categories are included. <i>Product Marketing Start Date</i>	20190329	This is the date that the labeler indicates was the start of its marketing of the drug product.

<i>Route Name</i>	INTRAMUSCULAR; INTRAVENOUS; PARENTERAL; SUBCUTANEOUS	The translation of the Route Code submitted by the firm, indicating route of administration. The complete list of codes and translations can be found at www.fda.gov/edrls under Structured Product Labeling Resources.
<i>Substance Name</i>	BOS TAURUS ADRENAL GLAND; SUS SCROFA ADRENAL GLAND; IODINE; IRIDIUM; BOS TAURUS PARATHYROID GLAND; BOS TAURUS PITUITARY GLAND; SUS SCROFA PITUITARY GLAND; BOS TAURUS SPLEEN; SUS SCROFA SPLEEN; SPONGIA OFFICINALIS WHOLE; BOS TAURUS THYMUS; SUS SCROFA THYMUS; THYROID, BOVINE; THYROID, PORCINE; LEVOTHYROXINE; LIOTHYRONINE; FUCUS VESICULOSUS; SUS SCROFA PARATHYROID GLAND	This is the active ingredient list.
